Dear Parents,

We have always endeavoured to provide your ward a secure environment in the school. This, however, is not possible without your cooperation. We would like to remind you of a few points that have been emphasized in the past too.

If your ward travels by a private van, RTV, Tempo Traveller, please ensure that:

1. the vehicle is well maintained, and running on company fitted CNG.
2. there is a conductor along with the driver.
3. the driver and conductor are licensed and experienced.
4. the police verification of the driver and conductor is done. You have a copy of the verification papers.
5. you have the telephone number and other contact details of the owner, driver and conductor of the vehicle.
6. you have all the details of the route covered by the vehicle.

We appreciate that in response to our previous reminders, a large number of parents now park their cars away from the school and encourage their wards to walk to the school gate. However, there are still many who insist on parking in front of the gate.

1. We would like to reiterate that the main gate is where the majority of the students enter and disperse and thus it is necessary that the approach to this gate be kept free and open, for the safety of students.
2. The area around the school is a **NO HONKING** zone. We request you to refrain from blowing the horn in the vicinity of the school.
3. Overcrowded private transport vehicles are a threat to your ward's safety. So, as far as possible, try to have your ward travel by the school bus.
4. **In case your ward travels by private transport, please fill in the undertaking and send it back to the class teacher latest by Wednesday, 31 July 2024.**
